5. Arrival loading & unloading: You must set up in your pre assigned location. Maps and acceptance letter will be mailed early in July. There will be vendor parking within a short distance offsite.

6. Deposit-License-Insurance-Health Department: Vendor agrees to pay a non-refundable deposit to Spirit of the Lakes. Vendor will also provide a copy of Vendor's third party and public liability insurance policy. The minimum face value shall be \$1,000,000.00 liability per occurrence. Vendor shall provide a current copy of their Minnesota Certificate of Health authorization to sell food items.

7. Waste Removal: Each Vendor must provide at least 1 large trash container with trash liners for their booth and keep their area clean. Vendor agrees to remove all waste, food by-products, excess food, cooking grease, and other by-products of food service operation from the site, and to pick up the immediate area surrounding their vending site to the satisfaction of the committee officials.

Neither the Spirit of the Lakes Festival, Inc., City of Mound, Maund Entertainment, Inc. nor any representative of the Spirit of the Lakes Festival shall be held responsible for any damage or loss to equipment incurred for any reason including inclement weather.
